## **APPENDIX 2: TABLE OF INELIGIBLE APPLICATIONS**

These applications did not achieve the 50% threshold.

Meesden Village Hall Committee	Plant fruit trees in grasslands owned by Parish Council which is adjacent to the Village Hall.	Not supported on this occasion as the panel noted that free trees were available from The Woodland Trust.  Application was weak around consultation and community benefits. The panel agreed the project in principle and applicant will be invited to reapply for a more ambitious project (larger trees, wildflower meadow) that engages with residents and stakeholders in the community and delivers a community planting event and ceremony at the village hall. This type of event would increase footfall not only to field but hall.
Red Kite Rape Crisis Centre	Establish and deliver recovery focussed services for survivors of childhood sexual abuse, rape and sexual assault by setting up a telephone helpline based in Ware. It is estimated that helpline will take 1,000 calls from people across south east Hertfordshire.	Reject on this occasion as application incomplete. The panel acknowledged the service was a good cause and that the trustees had a wealth of experience and appropriate skills. However quotes received were not for the equipment listed in application and there was no information on whether the group had a lease on the proposed office space. Applicant will be encouraged to reapply once detailed plans are in place. The application did not demonstrate evidence of need, how proposal would improve existing offer, community engagement, how volunteers would be recruited/trained and little detail on the services to be provided.
