NOTICE IS HEREBY GIVEN that the East Hertfordshire District Council with the consent of Hertfordshire County Council has made the above Order under the Road Traffic Regulation Act 1984. The general effect of the Order will be to make amendments to the current parking zone B4 in Portland Road and Newtown Road, Bishop's Stortford as specified in the Schedules to this Notice. The Order will come into effect on 20 September 2021.

Any person wishing to question the validity of the Order, or of any provision contained in it, on the grounds that it is not with the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or any instrument made under it has not been complied with in relation to the Orders, may within 6 weeks from the date of this Notice apply to the High Court for this purpose.
