

Subject: Review of polling districts and polling places - Hertford Sele

Dear Councillors and Colleagues.

Many thanks to all who responded to the consultation on East Herts' recent review of polling districts and polling places.

In relation to Hertford Sele Ward the issue has been raised both previously and during the consultation of the lack of a polling place in the area of Campfield Road/Mount Road/Valeside, and the distance and hilly nature of the walk from this area to the existing polling place at The Sele School Training Hub.

In view of the points made I intend to recommend that the polling district HSE1 should be split, with the Campfield Road area forming a polling district of its own. This will enable an alternative, more convenient polling place to be allocated to electors in this area as and when such a venue is identified.

So far however, no suitable premises within the area itself have been found. Two possible venues have been suggested for investigation – the Apollo Recording Studios in Mimram Road and the Kingdom Hall of Jehovah's Witnesses in Hertingfordbury Road. However as you will be aware both of these are on the other side of the A414 and are outside Sele Ward. Officers are enquiring as to their possible availability but subject to this I would welcome your feedback on their suitability or otherwise as a possible polling place for electors in the Campfield Road area in place of The Sele School.

In addition, if you are aware of any potential venues in Valeside or Campfield, Ashley, Chelmsford or Mount Roads themselves or very nearby I would be grateful for your suggestions.

## **Comments on Polling District Review**

#### **Clir Calvin Horner**

The comments below relate to Bishop's Stortford Wards where I have suggested amendments to the polling district boundaries or suggestions for alternative polling station arrangements.

#### **BS All Saints**

BSA1 and BSA2 - I propose an alteration to the boundary between BSA1 and BSA2 whereby the properties in Hockerill Street, Crown Terrace, Red Lion Court, Bakers Court, Dane Street are placed in BSA1. All Saints vestry is considerably closer to these roads than either of the suggested polling stations for BSA2 and is currently the polling station for Crown Terrace.

BSA2 — I would suggest Bishop's Stortford Bowls Club and Hockerill Cricket Club as replacements for Thorn Grove School. The former is located in Bowling Lane, off Beldams Lane and the latter on Beldams Lane. Whilst both are in Uttlesford they are within easy walking distance from the majority of BSA2 (see note above on Hockerill Street area) and the former has a car park.

BSA4 – I propose using South Mili Arts in preference to Holy Trinity Church. South Mili Arts has already been the polling station for Tanners Wharf and is more convenient for both Tanners Wharf and the Goods Yard flats as it is closer by foot and has a car park.

#### **BS Central**

No comments

#### **BS North**

BSN3 – Should neither Charringtons House nor the Water Lane Hall be available because of the redevelopment of Old River Lane, I would suggest several possible locations for all or part of BSN 3 in preference to either Windhill Church Centre or Holy Trinity Church, as they are both outside the proposed polling district. These suggestions include Avanti Meadows School, the Community Room at Grange Paddocks Leisure Centre and Northgate End Young Persons Centre.

## **BS Parsonage**

BSP1 – I propose that the southern section of Castle View, Hockerill Street, Kingfisher Way, Heron Court, Kings Court, Fuller Court, Stansted Road south of All Saints Close and All Saints Close form a separate polling district to vote at All Saints Church Vestry as this is considerably closer than Parsonage Community Hall by foot.

#### **BS South**

BSS1 – I would suggest Bishop's Stortford Baptist Church Centre, Twyford Road, (contact Tim Kingston-Hepner 01279 507575) which has two buildings that may be suitable to serve as a polling

station in preference to Thorley Community Centre as it is located within the proposed polling district and has a large car park.

BSS2 – suggestions would be Thorley Community Centre or the Barnabas Centre in Church Lane, Thorley

BSS3 & BSS4 - in addition to the Bishop's Stortford Baptist Centre I would also suggest the Barnabas Centre, Church Lane, Thorley which is part of Thorley Parish Church in preference to St. Michael's Mead Community Centre.

#### **BS Thorley Manor**

BST1 - Consideration should be given to having two polling Districts for the Bishop's Stortford Thorley Manor South Town Ward. The first including St. Michael's Mead (former BSO3) and the part of former BSO2 west of the by-pass, to vote at St. Michael's Mead Community Centre. The second to include the remainder of former BSO2 within the ward, to vote at Thorley Community Centre, provided there is adequate space. Such an arrangement will provide polling stations within reasonable walking or driving distance for most electors and Thorley Community Centre already serves as a polling station.

I wanted to get back to you with comments on polling places before Friday.

Re Kingsmead – I think that the site on Ware Rd would be a welcome addition but I am concerned by the lack of places in the east of the ward given that the nearest site is the Pinehurst Community Centre at the top of the steep hill. Is there an opportunity to make use of Ware Rd Day centre, which is HCC-owned, I believe, or one of the buildings at Wheatcroft School? Kingsmead Residents Assoc contacted me to express their concern and I believe they have contacted you. I think the hill could be a significant issue for many people in the Ware rd area and something at the bottom of the hill would seem a must.

Re Bengeo: If the Bengeo Club is unavailable, would the Bengeo Parish Hall on Duncombe rd be a suitable backup for HBE2?

For Hertford Castle, could the Quaker Room at the Friend's Meeting House be employed as a replacement for the River Room? Or Wallfields itself, or the community hall at All Saint's Church?

Statistics show that since the polling station in that area was removed the actual number of voters has dropped considerably, presumably because they cannot travel to the Sele Hub. There is an urgent need for a polling station in this area as these people are being deprived of their legal right to vote.

Hi John,

Some further suggestions on Stortford.

BSA2: The most obvious suggestion would be the Hert and Essex Sports Centre on Beldams Lane. Another alternative in the ward might be the Nags Head PH, although as a busy pub is likely to be less ideal. There are also two other potential venues on Beldams Lane: the Bishop's Stortford Bowling Club and the Hockerill Sports & Social Club. Both are just outside the ward (not a problem in itself), but are actually in Essex. I must say I've never had to think before about whether that is even legal or not before!

BSN3: Grange Paddocks would be the obvious and most suitable venue. Another alternative should Grange Paddocks or Northgate End not be suitable would be the Town Council building on Windhill which is just outside the ward. Again, the TC is far from ideal (parking), and is a long way from the North of the polling district. It would be an interesting question as well whether the main table in the Council Chamber could actually be moved out of the room!

## **Dear Electoral Services Manager**

Having taken a straw poli of members I am writing on behalf of Kingsmead Residents Association (KRA) to object to the use of Pinehurst Community Centre as a new polling station for the Hertford Kingsmead polling district HKI2 because the logistics of the centre mean that it will be a large disincentive to voting and may disenfranchise those with mobility or other issues because of the logistics associated with travelling from much of the HKI2 area but particularly Ware Road/Mead Lane and surrounding streets. Stanstead Road has a very steep hill, a narrow pavement and high traffic levels with associated higher speeds than the speed limit. Due to this anyone with a disability or who is getting older or who has some minor mobility issues will find it difficult to walk from the 'bottom' of the hill to the top which will mean that more people will need to drive to vote.

Which introduces the second logistical issue with Pinehurst Community Centre: one of the challenges on the Pinehurst estate is around parking with a limited amount of on street parking spaces coupled with the fact that the garages on the estate are not wide enough for a car to drive in and allow the doors to open meaning that the majority of residents are forced to park on street. This means that the roads around the community centre and the entrance road from Stanstead Road are congested meaning that journeys will cause even more congestion issues on the estate plus that the additional voters will struggle to find parking spaces.

The Pinehurst community centre is also relatively small with restricted corridor access which caused much of the issues with the use of Braziers Field as people were having to wait to go in or out plus squeeze past those queuing to go in at the last election due to the restricted corridor width. It's likely that the check in process for voters may cause delays this year due to the new requirement to present ID before a voter can vote which is likely to cause queuing. Having double the number of voters allocated to Pinehurst Community Centre may exacerbate this issue

As such we would like to suggest alternative venues for a new polling station to serve HKI2 in order of preference:

- a. Ware Road Day Centre this is ideally located roughly in the centre of the HKI2 polling district and, by its nature provides adequate disabled access plus should also permit indoor queuing
- b. Pioneer Hall, Ware Road this is a large hall which reduces the issues with queuing obstructing entrance and egress plus allows for queuing inside and may mean that it could be used as a double centre for HKI2 and HKI3

c. Methodist Hall, Ware Road - this is a smaller hall and it is already allocated as a voting location for HKI3. It would be preferable to 'double bubble' with HKI3 but not optimal as there is not the room to allow sufficient internal queuing d. Braziers Field - location is preferable to options b and c but it needs an improved layout with linear voting booths rather than the four booth central layout plus the queue has to stand outside which is not ideal in poor weather

One thing I would note that as a voter that queued for over 30 mins to vote at Braziers Field last election is that there were a number of issues with Braziers Field including the time to book people in and check them off the list, having to dance around the queue to get in and out of building plus the poor voting booth layout restricted the limited space in the room even further. I witnessed one voter in front of us giving up on voting after waiting for 15 mins and I would ask that you compare turn out figures for HKI2 over the past three elections to determine whether the long queue had an effect.

KRA are extremely concerned that the current plan for voters from HKI2 to vote in Pinehurst Community Centre will mean that the turn out for HKI2 will reduce due to the logistics issues and would ask that if you do move forward with this plan despite objections that you assess the impact on voter turn out for HKI2. Please do not hesitate to contact us should you have any queries or would like to discuss this matter further

I note revision to proposed Polling Stations within B.S. South Ward.

Another suggestion for consideration as the Thorley Christian Centre will not be available is to use Richard Whittington School. Residents have in the past walked to Thorley Christian Centre thereby reducing the need to drive to this Centre which does not have adequate parking provision which is why drivers used to park in the Thorley Sainsburys Car Park and use pedestrian crossing to access Vicerons Place/Christian Centre to vote. The loss of this venue will be greatly felt within the community.

If I understand your e.mail correctly, you are looking at the following venues for voting: Thorley Hill School, Richard Whittington School (which I previously suggested), plus St Michaels Mead Community Centre.

Thorley Community Centre does not offer ease of access to South Ward voters at all - it is located next to The Harvest Moon P.H. located in Friedburg Avenue. Parking will also be a problem during peak voting times.

Thank you John for the update. I note with interest the possible loss of St Mary's School in Ware as a polling station for WSM4, which would be disappointing. I will ask around the Town Council for any alternative locations nearby to serve the Kingsway area.

One possibility would be to use the Scout Hut in Poles Lane which is already in use as a polling station for the Old Vicarage Estate area of Ware St Mary's Ward (WSM1), and is still within walking distance of the Kingsway area. I haven't had the impression in the past that this station is excessively busy, although I don't know whether the interior space is considered sufficient to cover two subsections of the ward rather than one. North West Ware is rather short of community facilities and I'm not aware at present of any other obvious options.

Another possibility might be Wodson Park, but this is outside the ward and is also not easily accessible by foot, cycle or public transport from the Kingsway area.

Thank you very much for these details.

I understand the decision not to have the room at Braziers Field as a polling station. It is however very disappointing for the large number of frail and vulnerable residents in that area.

I fear the residents who have used the Braziers Field station in the past would struggle to get up the hill to the proposed extra station at Pinehurst Community Centre.

I wonder if you would please consider some other options.

The Methodist Church Hall on Ware Road could easily accommodate an extra polling station. There are several rooms in there and access could be from the front and the back of the building for the different stations. The hall is also closer to the town centre and on the flat so easier for residents to walk and access on their way to town. There are also better transport links.

The Zoo Café – former Pioneer Hall – next to the Methodist Church Hall would also be a suitable venue and has some of the same benefits.

The Ware Road Day Care Centre at the bottom of Stanstead Road is closer to the Braziers Field station and has good accessibility. It also has a car park and good transport links. It is run by HCC and I don't know if they would grant permission for it's use. It would also be a good alternative.

#### **Dear Electoral Services**

Buckland & Chipping Parish Council wishes to make the following comment for Buntingford Ward (pages 18-19):

PD Ref BUN1: The Countryman Inn, Ermine Street, Chipping SG9 OPG.

The Parish Council does not consider this to be a secure venue for the polling station. The property is up for sale/development and therefore its availability cannot be relied upon.

There are two possible alternative venues in the parish:

- 1. St Andrew's Church, Buckland: No longer used for church services and is now under the control of the Churches Conservation Trust (CCT). It is understood the CCT has no objections to the church being used as a polling station, for which there is a precedent in various parts of the country. The disadvantage of the venue is that access might be less easy in wet winter weather.
- 2 Buckland Barn, Lower Farm, Buckland, Buntingford SG9 OPS: Recently closed down as the venue of the annual Christmas at Buckland Barn event.

Thank you for taking these comments into consideration.

Postal voting would be the best way forward for many in my opinion. I would suggest that some form of advanced notification, when agreed and confirmed, is released to residents to allow enough time to obtain a postal vote. This applies to other Wards too in B.S. Thank you for the opportunity to comment on the proposed polling places review.

I am particularly interested in the proposals for the new Braughing and Standon Ward. The inclusion of existing polling stations that residents are familiar with make eminent sense, including the Old Boys School in Braughing, the Standon Village Hall and the Community Centre in Puckeridge, which are also placed in the most densely populated parts of the ward. However, I am unsure about the inclusion of High Cross Village Hall as a polling station for this Ward.

High Cross Village Hall does not lie within the Ward boundary, nor is it close to the boundary. It lies within the new Ware Rural Ward and is indeed included in the list of polling stations for Ware Rural.

Is it appropriate to have a polling station outside of the Ward boundary such as this? Can a polling station be used for elections in more than one Ward given that parish council elections will also be taking place on the same day?

Thank you for circulating the proposals for polling stations for the May 2023 elections. I have looked in particular at the Ware area because of the forthcoming ward boundary changes.

The proposals as outlined seem sensible and pragmatic, and I would support these proposals and have no suggestions for improvement. I see that the proposals for Ware Trinity also make appropriate mention of possible future changes for 2027 depending on progress in the N&E Ware development (WARE2).

Some polling stages are on the edges of wards (Ware St Mary's WSM2/3) or in other wards (Ware Trinity WTR1/4) but I agree with the conclusion that no obviously suitable alternative locations are apparent. Possibilities might include Chauncy School or St Catherines School for WSM, and Priorswood School for WTR1, but residents do not seem to have objected to walking to the existing venues, and community/church halls as currently used may be preferable to schools to avoid disrupting children's education.
