NOTICE IS HEREBY GIVEN that the East Hertfordshire District Council (pursuant to arrangement made with Hertfordshire County Council) has made the above Orders under the Road Traffic Regulation Act 1984, The general effect of the Orders will be to create some shared parking facilities for resident/Town Centre Business Permit Holders within the Parking Zone B7, Bishop's Stortford as specified in Schedule 1 to this Notice and waiting restrictions on various roads in East Hertfordshire District as specified in Schedule 2 and 3 to this Notice, eligible addresses for Town Centre Business Permits as specified in Schedule 4 to this Notice and details of charges in respect of Town Centre Business Permits specified in Schedule 5 to this Notice. The Order will come into effect on Monday 9th April 2018.
